Masonic Home of Montana. By adoption of the Grand Master's Address, and in compliance with the Constitution and Code of Statutes, in order to facilitate a clear and distinct separation of the Masonic Home and the Grand Lodge of Montana, the following were adopted: (1) The Code of Statutes of the Grand Lodge of AF&AM of Montana were amended, removing references to the Masonic Home of Montana. (2) Reciprocally, the Masonic Home will likewise remove Masonic reference from their Articles of Incorporation and By-Laws. (3) Finally, Trustees of the Masonic Home Board will appoint their successors. In order to carry out 2 and 3, the Masonic Home Board may do any and all things necessary to effectuate this, including but not limited to amending the Articles of Incorporation for the Masonic Home of Montana, and amending its By-Laws. Approved by the Craft assembled at the 150th Annual Communication.	Approved
